The Drinking Water Program: An Overview

The EPA established the Public Water System Supervision (PWSS) Program under the authority of the 1974 Safe Drinking Water Act (SDWA). Under the SDWA and the 1986 Amendments, EPA sets national limits on contaminant levels in drinking water to ensure that the water is safe for human consumption. These limits are known as Maximum Contaminant Levels (MCLs) and Maximum Residual Disinfectant Levels (MRDLs). For some regulations, EPA establishes treatment techniques in lieu of an MCL to control unacceptable levels of contaminants in water. The Agency also regulates how often public water systems (PWSs) monitor their water for contaminants and report the monitoring results to the states or EPA. Generally, the larger the population served by a water system, the more frequent the monitoring and reporting (M/R) requirements. In addition, EPA requires PWSs to monitor for unregulated contaminants to provide data for future regulatory development. Finally, EPA requires PWSs to notify their consumers when they have violated these regulations. The 1996 Amendments to the SDWA require consumer notification to include a clear and understandable explanation of the nature of the violation, its potential adverse health effects; steps that the PWS is undertaking to correct the violation and the possibility of alternative water supplies during the violation.

The SDWA applies to the 50 states, the District of Columbia, Indian Lands, Puerto Rico, the Virgin Islands, American Samoa, Guam, the Commonwealth of the Northern Mariana Islands, and the Republic of Palau.

The SDWA allows states and territories to seek EPA approval to administer their own PWSS Programs. The authority to run a PWSS Program is called primacy. For a state to receive primacy, EPA must determine that the state meets certain requirements laid out in the SDWA and the regulations, including the adoption of drinking water regulations that are at least as stringent as the Federal regulations and a demonstration that they can enforce the program requirements. Of the 56 states and territories, all but Wyoming and the District of Columbia have primacy. The EPA Regional Offices administer the PWSS Programs within these two jurisdictions. The Oklahoma Department of Environmental Quality (DEQ) is the primacy agency for the State of Oklahoma Drinking Water Program.

The 1986 SDWA Amendments gave Indian Tribes the right to apply for and receive primacy. EPA currently administers PWSS Programs on all Indian lands except the Navaho nation, which was granted primacy in late 2000.

Annual State PWS Report

Each quarter, primacy states submit data to the EPA Safe Drinking Water Information System (SDWIS/FED), an automated database maintained by EPA. The data submitted include, but are not limited to, PWS inventory information, the incidence of Maximum Contaminant Level, Maximum Residual Disinfectant Level, monitoring, and treatment technique violations; and information on enforcement activity related to these violations. Section 1414(c) (3) of the Safe Drinking Water Act requires states to provide EPA with an annual report of the violations in each of six categories: MCLs, MRDLs, treatment techniques, variances and exemptions, significant monitoring violations, and significant consumer notification violations. Violation and enforcement action data are stored in the SDWIS/FED database. The tables in this report are based largely on data retrieved from DEQ databases.

Public Water System

A Public Water System is defined as a system that provides water via piping or other constructed conveyances for human consumption to at least 15 service connections or serves an average of at least 25 people for at least 60 days each year. There are three types of PWSs. PWSs can be community (such as towns), non-transient non-community (such as schools or factories), or transient non-community systems (such as rest stops or parks). For this report, the acronym “PWS” means systems of all types unless specified in greater detail.

Maximum Contaminant Level

Under the Safe Drinking Water Act (SDWA), the EPA sets national limits on contaminant levels in drinking water to ensure that the water is safe for human consumption. These limits are known as Maximum Contaminant Levels (MCLs).

Maximum Residual Disinfectant Levels

The EPA sets national limits on residual disinfectant levels in drinking water to reduce the risk of exposure to disinfectant byproducts formed, when PWSs add chemical disinfectant for either primary or residual treatment. These are known as Maximum Residual Disinfectant Levels (MRDLs).

Treatment Techniques

For some regulations, the EPA establishes treatment techniques (TTs) in lieu of an MCL to control unacceptable levels of certain contaminants. For example, treatment techniques have been established for viruses, some bacteria, and turbidity.

Variances and Exemptions

A primacy state can grant a PWS a variance from a primary drinking water regulation if the characteristics of the raw water sources reasonably available to the PWS do not allow the system to meet the MCL. To obtain a variance, the system must agree to install the best available technology, treatment techniques, or other means of limiting drinking water contamination that the Administrator finds are available (taking costs into account), and the state must find that the variance will not result in an unreasonable risk to public health. At the time the variance is granted, the state must prescribe a schedule (including increments of progress) the PWS will follow to come into eventual compliance with the MCL. Small systems (those serving 3,300 or fewer persons; or 10,000 or fewer persons with the Administrator’s approval) may also be granted variances if they cannot afford (as determined by application of the Administrator’s affordability criteria) to comply with certain MCLs (non-microbial, promulgated after January 1, 1986) by means of treatment, alternative source of water, or restructuring or consolidation. Small systems will be allowed three (3) years to install and operate EPA approved small system variance technology. The variance shall be reviewed not less than every five (5) years to determine if the system remains eligible for the variance.

A primacy state can grant an exemption temporarily relieving a PWS of its obligation to comply with an MCL, treatment technique, or both if the system’s noncompliance results from compelling factors (which may include economic factors) and the system was in operation on the effective date of the MCL or treatment technique requirement. A new PWS that was not in operation on the effective date of the MCL or treatment technique requirement by that date may be granted an exemption only if no reasonable alternative source of drinking water is available to the new system. Neither an old or a new PWS is eligible for an exemption if management or

restructuring changes can reasonably be made that will result in compliance with the SDWA or improvement of water quality, or if the exemption will result in an unreasonable risk to public health. The state will require the PWS to comply with the MCL or treatment technique as expeditiously as practicable, but not later than 3 years after the otherwise applicable compliance date.

Monitoring

A PWS is required to monitor and verify that the levels of contaminants present in the water do not exceed the MCL. If a PWS fails to have its water tested as required or fails to report test results correctly to the primacy agent, a monitoring violation occurs.

Significant Monitoring Violations

For this report, significant monitoring violations are generally defined as any major monitoring violation that occurred during the calendar year of the report. A major monitoring violation, with rare exceptions, occurs when no samples were taken or no results were reported during a compliance period.

Consumer Notification

Every Community Water System is required to deliver to its customers a brief annual water quality report. This report is to include some educational material, and will provide information on the source water, the levels of any detected contaminants, and compliance with drinking water regulations.

Significant Consumer Notification Violations

For this report, a significant public notification violation occurred if a community water system completely failed to provide its customers the required annual water quality report.

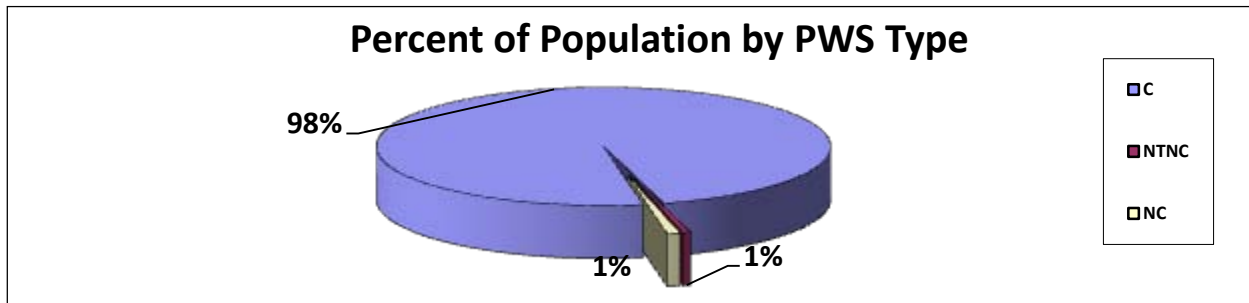
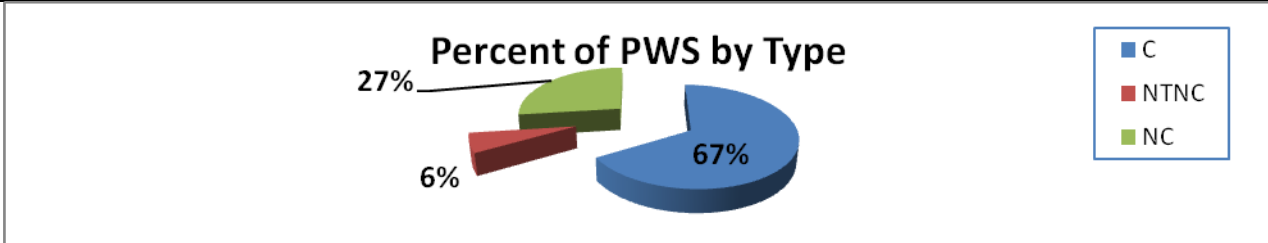
Public Water Supply Inventory – Calendar Year 2010

The SDWA defines a Public Water Supply system (PWS) as a system that provides water via piping or other constructed conveyances for human consumption to at least 15 service connections or serves an average of at least 25 people for at least 60 days each year. There are three types of PWSs. PWSs can be community (such as towns and rural water districts), non-transient non-community (such as schools or factories), or transient non-community systems (such as rest stops or parks). For this report, the acronym “PWS” means systems of all types unless specified in greater detail.

The Oklahoma Department of Environmental Quality also recognizes smaller systems as public water supplies. These public water supplies are referred to as minor or non-public water systems. Violations and enforcement actions for minor public water supply systems are not reported to SDWIS and are not included in this report.

The number of Community, Non-Transient Non-Community, and Non-Community water systems and the population served by each is given in the following table. The average number of individuals that consume water from each system each day is used to calculate the number of residents served by a public water supply. Because some systems are restaurants, tourist attractions, etc., individuals may be counted more than once due to where they patronize or work. Out-of-state individuals that visit or do business in the state are also counted.

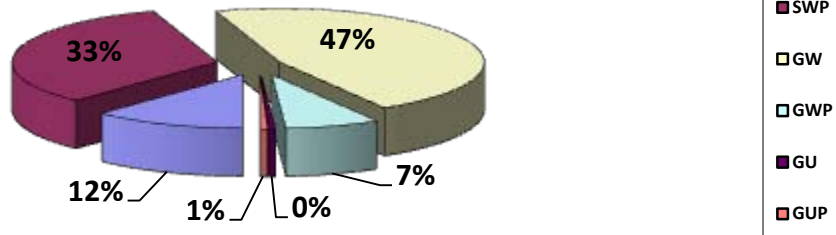

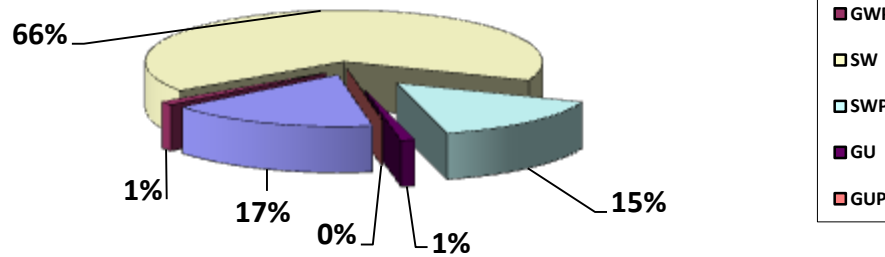
Public water supply systems may receive their water from groundwater wells, surface water impoundments or reservoirs, or purchase water from other systems for their primary source of drinking water or for supplemental supply. The number of groundwater, surface water, and purchase systems and the population served by each type is given in the table below. Eighty-one percent (81%) of the population is served by surface water or purchased from surface water systems.

Percent of PWS by Source



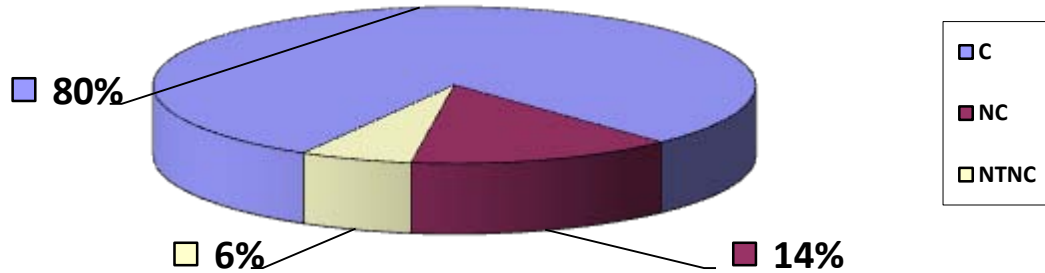
Percentage of Population by Source Type

Comments and Remarks

The State of Oklahoma's Public Water Supply Program currently oversees one thousand six hundred and forty-one (1,641) public water supplies ("PWS") that meet the federal definition of a PWS. Of these one thousand six hundred and forty-one (1,641) systems, one thousand four hundred and fifty-one (1,451) or eighty-eight percent (88%) of these systems reported no maximum contaminant level (MCL) violations.

Seven (7) systems had twenty-seven (27) violations for exceeding the MCL for arsenic. Two (2) systems had two (2) violations for arsenic monitoring. Three (3) systems had three (3) violations for exceeding the MCL of the inorganic chemical contaminant (IOC) group. There was one (1) violation by one (1) system for IOC group monitoring. Twenty-eight (28) systems had sixty-eight (68) violations for exceeding the nitrate MCL standard in at least one of their wells during the calendar year of 2010. Thirty-four (34) systems had forty-seven (47) nitrate monitoring violations. There were zero (0) systems with synthetic organic contaminant (SOC) group MCL violations. There were zero (0) SOC monitoring contaminant group violations. Two (2) systems had six (6) volatile organic chemical contaminant (VOC) group MCL violations. Eight (8) systems had three hundred and sixty (360) VOC contaminant group monitoring violations.

Ten (10) systems had fifty-six (56) Radionuclide MCL violations in the calendar year 2010. Ten (10) systems had one hundred and forty-four (144) violations for Radionuclides monitoring reported for 2010. There were three hundred and thirty-six (336) violations of the Stage 1 Disinfectants and Disinfection Byproducts Rule (Stage 1 DBPR) MCL by eighty-nine (89) systems. Thirty-four (34) systems had one hundred and one (101) violations of the Stage 1 DBPR Treatment Technique requirement. Forty-three (43) systems had one hundred and five (105) monitoring violations for the Stage 1 DBPR.

Three (3) systems had three (3) Total Coliform Rule ("TCR") Acute MCL violations, meaning three (3) mandatory Boil Orders were issued for these PWSs that tested positive for fecal coliform or E-coli. Seventy-two (72) PWSs had eighty-one (81) TCR MCL violations that indicated a coliform positive sample. Four hundred and twenty-nine (429) systems had nine hundred and twelve (912) routine monitoring violations for TCR. Seventy-two (72) systems had eighty-three (83) repeat monitoring violations for TCR.

All surface water PWSs in Oklahoma are required to provide filtration. None of the one hundred and ninety-eight (198) surface water systems violated the Surface Water Treatment Rule (SWTR) for treatment technique. None of the systems were in violation for SWTR monitoring and reporting. None of the systems had Filter Backwash Recycle Rule violations for treatment technique or monitoring and recordkeeping. There were forty-one (41) turbidity treatment technique violations by nineteen (19) systems for Interim Enhanced Surface Water Treatment Rule ("IESWTR"). There were six (6) monitoring and reporting violations by one (1) system for IESWTR. None of the systems had treatment technique violations for the Lead and Copper Rule. One hundred and thirty-two (132) systems had one hundred and sixty-nine (169) monitoring violations for the Lead and Copper Rule.

The total count of public water systems in violation was one thousand one hundred and twenty-two (1,122). Some public water systems may be counted more than once if they incurred multiple violations. The actual total number of public water systems in violation for MCL was one hundred and ninety (190). The total number of violations for the calendar year of 2010 was two thousand nine hundred and fifty-seven (2,957).

The Oklahoma Department of Environmental Quality issued two thousand four hundred and forty (2,440) enforcement actions in response to the violations listed in this report. These enforcement actions consisted of two thousand one hundred and fifteen (2,115) informal enforcement letters. Three hundred and nineteen (319) Notices of Violation (“NOVs”)/Consent Orders (“COs”), zero (0) Administrative Compliance Order (“ACOs”), and five (5) Boil Advisories we administered. One thousand two hundred and twenty-two (1,222) systems were returned to compliance during the calendar year of 2010.

An informal enforcement document is the first document issued to facilities when they fail to monitor. A Notice of Violation is the first formal enforcement document issued to facilities when they exceed maximum allowable levels or fail to meet Department of Environmental Quality rules and regulations concerning matters such as construction deficiencies or operating procedures. A Consent Order is typically the next order issued. The Consent Order is an order that contains an agreement between the water system and the DEQ, and details the tasks and deadlines for correcting the cited violation. An Administrative Consent Order is an order that is issued when time is limited, and there is a significant health hazard, or the water system refuses to agree to the Consent Order. In an Administrative Consent Order, the DEQ tells the water system what tasks need to be completed and sets deadlines for the completion of these tasks. Both the Consent Order and the Administrative Consent Order have stipulated penalties for failing to meet the required deadlines. Boil Advisories are issued to systems that have “acute” or “fecal positive” bacteriological violations. Boil Advisories can also be issued for exceedance of turbidity, insufficient chlorine residual and pressure. Boil Advisories require immediate notice to all consumers in order inform the public of how to make their water safe for human consumption.
