# 8. Rulemaking – OAC 252:410 Radiation Management

The proposed rulemaking is designed to clarify the appropriate fee category for various radiation machines. It changes the description of radiation machines in some fee categories so that the terminology of Appendix A corresponds to rule text, and adds one fee category to correct an ambiguity. No changes to fees will result from this rulemaking.

# 15. Rulemaking – OAC 252:624 Minor Public Water Supply Systems

The proposed rulemaking clarifies and consolidates all construction, operation and maintenance rules applying to minor public water supply systems into one set of rules separate from the more complex rules that apply to other public water supply systems. Currently, the rules dealing with minor public water supply systems are in two separate Chapters. The proposed rules also require an individual permit for slow sand filters; modify pre-testing requirements; add property ownership criteria; reduce the frequency of certain VOC testing; allow DEQ to require additional testing; and impose closure requirements.

Changes include removing outdated language; adding design and construction standards for new treatment techniques; integrating a supplemental information section into the rules; revoking requirements that are to be moved to Chapter 624; updating construction requirements to meet new EPA standards; and correcting errors and omissions.

# 17. Rulemaking – OAC 252:631 Public Water Supply Operation

The DEQ proposes to update its incorporation by reference of certain federal regulations from July 1, 2006, to July 1, 2007. The DEQ also proposes to increase public water supply annual fees by the rate of inflation since the effective date of the last fee modification and to provide for automatic fee adjustments for inflation. Other changes revoke requirements that are to be moved to Chapter 624; update language to meet EPA requirements and rule reference changes; set a minimum water pressure requirement throughout the distribution system; adopt new requirements for source water development; and recognize the type of testing required for new disinfection treatment techniques. The remaining changes correct errors and omissions.

# 19. Rulemaking – OAC 252:641 Individual And Small Public On-Site Sewage Treatment Systems

The proposed rules increase fees to compensate for increased program costs and provide for automatic fee adjustments for inflation. They also add options for the treatment and dispersal of wastewater; modify certain separation distances; require an installer maintenance period for aerobic systems; require use of soil profile descriptions for systems in Scenic River Corridors; establish property ownership criteria; and bring under the Chapter those systems that were previously categorized as standardized alternative systems.
