The Department is proposing is to: (1) clarify the definition of a "Minor Public Water Supply System"; (2) add the definitions for "Annular Space," "Human Consumption," "Individual Water System," "Multi-Family Dwelling," "PAS," and "WSC"; (3) add language to the minor public water supply rules that incorporates the existing Permit to Supply law as outlined in §27A-2-6-304; (4) create a "Certification of Exemption" for facilities that use the water solely for hand washing or toilet flushing; (5) grant authority for DEQ to approve variances; (6) add language creating separation distances from wastewater lagoons to be consistent with Water Resources Board regulations; (7) clarify language regarding separation distances from on-site sewage systems; (8) remove the

requirement of surface casings; (9) add language allowing bentonite clay for grouting material; (10) add language to allow for the use of pitless well adapters; (11) amend the appendix to show the changes to the rule and update drawings; and (12) other minor clarifications and corrections.
